



2024-2025 FINANCIAL AGREEMENT

Please read the following financial agreement carefully in order to completely understand the financial obligation to which you are committing yourself with the enrollment of your child(ren) at Pleasant Hill Christian School. If you have questions please call the school office.

REGISTRATION FEE: \$150/Child

The annual Registration Fee covers the cost of processing applications and other necessary requirements of school enrollment, and is a financial commitment on the part of our families which allows the administration to more accurately project enrollment, staffing, and curriculum needs. This fee is non-refundable.

LATE & RETURNED-CHECK FEE: \$25

All payments are due on the 1st of each month **beginning July 1**. Payments are to be made directly to the school. A late fee of \$25 will be assessed for each payment received after the 10th of the month. A charge of \$25 will be assessed for any check returned by the bank.

WITHDRAWAL FEE: \$75

The first month's tuition is non-refundable. A fee of \$75 will be charged for withdrawal after September 10, 2024.

PAST DUE ACCOUNTS

Accounts which become 60 days past due can result in the dismissal of the student(s) from the school until the account is brought current. Parents with past due accounts are responsible to call the bookkeeper and communicate their plan to bring their account current.

PAYMENT OPTIONS (see different tuition rates in table above)

For your convenience, four payment plans are available. Please check your payment plan choice:

- 12 equal monthly payments. **July 1, 2024**– June 1, 2025
- 11 equal monthly payments. **July 1, 2024**–May 1, 2025
- 2 payments. 1/2 tuition by **July 1, 2024** and 1/2 tuition by January 1, 2025
- 1 payment. Full tuition by **July 1, 2024**
